RESOLUTION NO. 28-2019

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SHERIDAN,
COLORADO, CANCELING THE CITY OF SHERIDAN'S NOVEMBER 5, 2019, CITY
COUNCIL ELECTION AND DECLARING THE CANDIDATES ELECTED AND
RESCINDING RESOLUTION NO. 24-2019**

WHEREAS, on July 22, 2019, City Council adopted Resolution No. 24-2019, approving an intergovernmental agreement with Arapahoe County to conduct a coordinated election for the November 5, 2019 election; and

WHEREAS, in accordance with state law, coordinated elections are subject to the requirements of the Uniform Election Code, C.R.S. § 1-1-101, et seq.; and

WHEREAS, the only matter currently before the registered electors of the City of Sheridan is the election of two councilors from Ward One, one councilor from Ward Two, and two councilors from Ward 3; and

WHEREAS, C.R.S. § 1-5-108 (1.5) provides that if the only matter before the electors in a nonpartisan election is the election of persons to office, and if, at the close of business on the sixty-third day before the election, there are not more candidates than offices to be filled at the election, including candidates filing affidavits of intent, the designated election official shall, if instructed by resolution of the governing body, cancel the election and declare the candidates elected; and

WHEREAS, the November 5, 2019 election is a non-partisan one, September 3, 2019 is the sixty-third day before the election, and currently there are not more candidates than offices to be filled at the election.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHERIDAN, COLORADO, THAT:

Section 1. The City Clerk as the City's designated election official is directed to cancel the November 5, 2019 election for councilors and declare as elected:

Ward One:	Dave Black, Councilor, four-year term
	Donald G. Smith, Councilor, two-year term
Ward Two:	Sally Daigle, Councilor, four-year term
Ward Three:	Dallas Hall, Councilor, four-year term
	Juanita Camacho, Councilor, two-year term

The City Clerk is further directed to provide notice by publication of cancellation of the election and post such notice as required by law.

Section 2. Upon the City Clerk's fulfillment of the duties set forth in Section 1, City Council, with the exception of honoring its financial commitment of payment of all prior election costs incurred by the County Clerk and Recorder (C.R.S. § 1-5-108 (5)), rescinds, in its entirety, Resolution No. 24-2019.


