RECORD OF PROCEEDINGS
March 25, 1993

A meeting of the Board was called to order by the Chairman, Cliff Mueller at 8:17 pm in the Sheridan Community Room. Trustees Mueller, Rowland and Hutcheson were present, absent Heath and Sitler. No guest was present.

Correspondence: A resignation from Patty Heath was read. A motion was made by Rowland, seconded by Mueller to accept it. Motion carried. Mr. Dale Smith was proposed as a Trustee to replace her, however, Mrs. Smith has had an accident recently and he will not be available until she improves.

Essay Contest: The essay contest form has been turned into the teacher. They thought it was very interesting. We hope to have many applicants for this contest. A motion was made by Rowland, seconded by Mueller to increase the first prize to a \$100.00 bond. Seconded and carried. Judges for the contest are Shirley Minter, Thea Hutcheson, and Dick Lynch. Pace will provide the second and third place prizes.

Minutes: A motion was made by Rowland, seconded by Mueller to approve the minutes of February 25, 1993 as presented. Motion carried.

General Membership Meeting: The Sheridan Council/Court room has been reserved for May 17 for this meeting. We hope to have the results from the essay contest so the winners can be announced. Cookies will be provided by Mueller. Styrofoam cups, plates, etc will be brought by Hutcheson. Mr. Dougherty will be invited to discuss the projected plans we have. Mr. Dale Smith will be asked to bring the painting of Peter Mangus which he purchased. Mr. Earl McCoy will be asked to do the introductions and the Sheridan Centennial film will be shown. It is also hoped that we will be able to get some artifacts to display. The drawing of Fort Logan from Englewood will be displayed and of course membership brochures will be available. Some the historical booklets done as programs for the Sheridan Celebrates programs will also be available.

New Trustee: A motion was made by Rowland, seconded by Hutcheson to table all items on the new business section relating to election of new trustee, new treasurer, and approval of the new account signers. Motion carried.

Incorporation: The Secretary will check on the renewal of the incorporation with the Secretary of State, as it expires May 24th, and no renewal form has been received.
