



**Sheridan Historical Society  
Trustee Meeting  
Tuesday at 5:30 PM  
September 23, 2025**

**Meeting Minutes**

The meeting was called to order by Dallas in the "River Point" community room in the Sheridan Municipal Center at 4101 S. Federal Boulevard at 5:30 pm.

The following board members were present: Ernie Camacho, Dallas Hall, Andrew Rogge, and Roger Rowland. There were no guests.

A motion was made by Ernie and seconded by Andrew to approve the minutes of July 22, 2025. The motion was approved.

**Treasurer's Report**

Roger reported the current balance is \$5,128.06. A motion was made to accept the Treasurer's Report by Dallas and seconded by Ernie. The motion passed.

**Correspondence**

There was no correspondence.

**Old Business**

Work is still pending on the supplemental history of the Sheridan Police Department. There are three tasks remaining to be completed. Information on the CLETA Certification is still needed. A list of officers needs to be completed from 2015 to the current time. Pictures need to be obtained for all the current officers. Roger has discussed with the chief and commander some ways for collecting the information for the list of officers.

Work has been started on the History for Alice Terry Elementary School. Roger has been reviewing the yearbooks from Alice Terry. The school does not have any yearbooks before 1979. The school opened in the fall of 1958. Roger has made three visits to the schools to review the yearbooks they do have. Short biographies have been completed on three of the eleven principals. Roger anticipates completing the history by spring or before.

An update was given by Andrew on the Covey home at 1913 Hamilton Place. A rezone has been requested for the property by the adjoining neighbor Valor Landscape. The city council

approved the rezone request from residential to business light-industrial. The owner expects to demolish the house and use the land for a storage area.

Andrew gave an update on the zoning change request application for Flying Saucer at 2500 W. Hampden. A neighborhood meeting was held during the summer about the proposal and the zone change process. The Planning Commission will hold a hearing next week on the request. The recommendation will be sent to City Council. The council will consider an ordinance on the zone change with a public hearing to be held in October in front of the council.

#### New Business

Sheridan Celebrates will be held on Saturday, September 27, 2025. This is an opportunity for the society to resume putting out an annual historical booklet for distribution at the event.

The school district is once again considering relocating their district offices from the lower campus to the main school building area previously occupied by SOAR Academy. SOAR has moved back into the high school building on Oxford Avenue into the southwest wing adjacent to the auditorium and music room. This was possible because of the continuing reduction in the number of students at the high school. They anticipate beginning the move later this year. They anticipate converting the lower campus into use for athletics. There are currently no locker room or athletic meeting room facilities adjacent to the football field.

The school district is also considering changing the location of high school graduation ceremonies back to the stadium. Graduation is a couple of weeks earlier compared to prior years, and harsh weather is a major consideration. The past couple of years graduation has been held on the School of Mines campus in Golden. There have been a couple of other church locations used since the theatre at Loretto Heights closed. The 2021 graduation commencement was held in the stadium.

There was a discussion about the scheduled November board meeting. A motion was made by Dallas and seconded by Ernie to cancel the November meeting because of the Thanksgiving Holiday. The motion was approved.

The meeting was adjourned at 5:54 pm.
